- 6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.

- That the Principal and Correspondent/ Manager of the school have 7. individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time.
